SALUTE - SMART LITTLE LENA -D - STALLION CONTRACT 11/12 SEASON

THIS AGREEMENT is made and entered into this _____ day of _____ 20_____.

1. Mare owner hereby agrees to breed their mare

to the stallion SALUTE - SMART LITTLE LENA -D .

A fee of \$3 300 inc GST is agreed upon and a deposit of \$330 inc GST is payable with this contract to confirm booking and before use of semen. \$1320 inc GST of the stud fee is to be paid when the mare is pronounced safe in foal at 45 days. If and when the AusQHA register SMART LITTLE LENA -D the balance of \$1650 inc GST will be due. In the event the foal is a colt that is gelded the remaining unpaid service fee will not be required to be paid.

2. The agistment fees on pasture is at the rate of \$20 plus GST per week for dry mare and \$25 plus GST per week for wet mares. Hand feeding is AT COST. Agistment and further veterinary fees shall be due and payable on or before re-delivery of the mare to owner.

3. All mares must be tractable and handled to lead. RICHARD BULL reserves the right to refuse any mare for service.

4. It is further agreed that should a stallion die or become unfit for service, or the above named mare should die, then this contract shall become null and void, and any money paid as part of the booking fee shall be refunded less any agistment and veterinary fees.

5. Mare owner agrees that RICHARD BULL will not be responsible for any disease, accident, sickness or death to mare owner's mare or foal, and that RICHARD BULL will exercise his judgment in supervising and caring for mares. Mare owner will likewise not be responsible for any disease, accident, sickness or death to other horses.

6. Mare owner agrees to have RICHARD BULL's veterinarian check mare owners' mare for normal breeding condition, and to perform such other veterinary services as RICHARD BULL deems necessary, at mare owner's expense. This includes worming, treating for infections, preventative measures, original examination, ultrasound, etc.

7. RICHARD BULL agrees to exercise reasonable diligence to settle the mare up to the 28TH day February 2012. In the event that the mare shall not become pregnant RICHARD BULL's liability shall be limited to refunding the balance of the deposit after deducting agistment and veterinary fees.

8. In the event that the mare aborts or if the foal does not stand and nurse, it is agreed that the owner may return the mare for breeding during the following breeding season and no stud fee will be charged for subsequent breeding. To be entitled to such subsequent breeding, the owner must deliver to RICHARD BULL, a certification by a licensed veterinarian attesting that the mare aborted or that the foal failed to stand and nurse, accompanied by the Stallion Breeding Certificate, and such delivery shall be made within ten (10) days of the date that the mare aborts or the foal is born.

9. It is agreed that all sums payable to RICHARD BULL be paid by cheque to RICHARD BULL, 'Tamarang', New England Highway, Tamworth OR via internet banking to RICHARD BULL - ANZ Bank BSB: 012 830 ACC: 905468425 and referenced with the invoice number issued with this contract and your surname.

10. When mare owner signs and returns one copy of this contract to RICHARD BULL including a copy of the mare registration papers and the deposit is paid as per clause 9. it will then be a binding contract on both parties subject to the above terms and conditions. This contract is not transferable or assignable.
